JOINT RESOLUTION OF THE CITIES OF
DAVIS, WEST SACRAMENTO AND WOODLAND
AND THE COUNTY OF YOLO

ANNEXATION BY THE SACRAMENTO MUNICIPAL UTILITY DISTRICT

WHEREAS, in early 2003, the Cities of Davis, West Sacramento and Woodland, and the County of Yolo requested the Sacramento Municipal Utility District (SMUD) consider the annexation of these cities and portions of Yolo County for the provision of electrical service; and

WHEREAS, the SMUD Board established specific criteria by which to assess the potential for annexation and the Cities of Davis, West Sacramento and Woodland and portions of Yolo County met those criteria; and

WHEREAS, the Cities of Davis, West Sacramento and Woodland, the County of Yolo and SMUD officials joined together to study the feasibility of SMUD annexing portions of Yolo County to provide electrical service; and

WHEREAS, these same agencies, in partnership, funded and contracted with R.W. Beck, Inc. to conduct a thorough analysis of the feasibility of the annexation of the Cities of Davis, West Sacramento and Woodland and the underlying portions of Yolo County by the Sacramento Municipal Utility District; and

WHEREAS, the results of the R.W. Beck "SMUD Annexation Feasibility Study" strongly indicate that annexation by SMUD of the Cities of Davis, West Sacramento and Woodland and the related portions of Yolo County would be beneficial to these communities as well as to the entire SMUD system and its current rate payers.

NOW, THEREFORE, BE IT JOINTLY RESOLVED, by the City Council of the City of Davis, the City Council of the City of West Sacramento, the City Council of the City of Woodland and the Board of Supervisors of the County of Yolo, that we together request the Board of Directors of the Sacramento Municipal Utility District annex our municipalities and the associated unincorporated areas for the provision of electrical service by SMUD; and

BE IT FURTHER RESOLVED that the Cities of Davis, West Sacramento and Woodland and the County of Yolo commit to continue to work jointly and wholeheartedly with the SMUD Board of Directors and SMUD staff to affect such annexation.
