## 7. Business Items.

- A. **437 J Street (Frank Skover) Abatement Plan:** The Commission is being asked to review and advise on whether the proposed replacement plans for siding, windows and trim, and other exterior details are consistent with *The Secretary of Interior's Standards for Rehabilitation* relative to the failure to comply with mitigation measures of Negative Declaration included in the conditions of approval for the project.
- **B.** Future Violations of Conditions of Approval/Violation of Code Requirements for Historic Resources. The Commission is being asked to discuss and direct staff to work with the City Attorney to draft potential penalties that could be imposed in the future on violators of conditions of approval and/or of the Historical Resources section of the Zoning Ordinance. Commissioners are encouraged to provide input to staff that can be shared with the City Attorney for consideration regarding penalties. A future agenda will contain the City Attorney's opinion on the imposition of penalties. The City Council would have to adopt any penalties recommended.
